WHEREAS, Section 177.08 further requires that said professional service contract, when in excess of \$50,000.00, must be approved by County Council; and
WHEREAS, this Council finds and determines, after reviewing all pertinent information, that is necessary and in the best interest of the County of Summit to authorize the County Executive, subject to the approval by the Board of Control, to execute a professional service contract with Ward & Associates for the valuation of all land and buildings for commercial, industrial, exempt, and public utility real estate, for the 2017 real estate triennial, in an amount not to exceed \$81,000.00;
NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
SECTION 1
The County Executive is hereby authorized, subject to approval by the Board of Control, to execute a professional service contract with Ward & Associates, for the valuation of all land and buildings for commercial, industrial, exempt, and public utility real estate, for the 2017 real estate triennial, in an amount not to exceed \$81,000.00.
