A Resolution requesting the County Fiscal Officer to advance, pursuant to Section 321.34 of the Ohio Revised Code all tax levy funds for tax year 2015/collection year 2016 to the County of Summit, for the Executive's Department of Finance and Budget, and declaring an emergency.

WHEREAS, pursuant to Section 321.34 of the Ohio Revised Code, when requested by resolution by a township, municipal corporation, board of education or any other political subdivision or taxing authority whose funds derived from taxes or other sources are payable by law to the County Fiscal Officer, the Fiscal Officer shall pay to said local authorities any money that may be in the County treasury to the accounts of the local authorities for the current fiscal year in which the request is made; and

WHEREAS, it is necessary to request the County Fiscal Officer to advance all tax levy funds for tax year 2015/collection year 2016; and

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

## SECTION 1

The County Fiscal Officer is hereby requested to advance, pursuant to Section 321.34, all tax levy funds for tax year 2015/collection year 2016 to the County of Summit.

## **SECTION 2**

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit, and for the further reason that it will immediately allow the County Fiscal Officer to advance all tax levy funds for tax year 2015/collection year 2016.

## **SECTION 3**

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

## **SECTION 4**

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
