7 **A Resolution requesting the County Fiscal Officer to advance, pursuant to Section 321.34**
8 **of the Ohio Revised Code all tax levy funds for tax year 2015/collection year 2016 to the**
9 **County of Summit, for the Executive's Department of Finance and Budget, and declaring**
10 **an emergency.**

12 WHEREAS, pursuant to Section 321.34 of the Ohio Revised Code, when requested by
13 resolution by a township, municipal corporation, board of education or any other political
14 subdivision or taxing authority whose funds derived from taxes or other sources are payable by
15 law to the County Fiscal Officer, the Fiscal Officer shall pay to said local authorities any money
16 that may be in the County treasury to the accounts of the local authorities for the current fiscal
17 year in which the request is made; and

19 WHEREAS, it is necessary to request the County Fiscal Officer to advance all tax levy
20 funds for tax year 2015/collection year 2016; and

22 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
23 of Ohio, that:

25 SECTION 1

27 The County Fiscal Officer is hereby requested to advance, pursuant to Section 321.34, all
28 tax levy funds for tax year 2015/collection year 2016 to the County of Summit.

30 SECTION 2

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the citizens of the County of Summit, and for the further reason that it will
34 immediately allow the County Fiscal Officer to advance all tax levy funds for tax year
35 2015/collection year 2016.

37 SECTION 3

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.

45 It is found and determined that all formal actions of this Council concerning and relating
46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
47 deliberations of this Council and of any of its committees that resulted in such formal action,
48 were in meetings open to the public, in compliance with all legal requirements, including Section
49 121.22 of the Ohio Revised Code.


