7 **A Resolution appropriating funds, in the amount of \$8,562,984.00, from a tax levy for the**
8 **Akron Zoological Park for tax year 2015/collection year 2016, for the Department of**
9 **Finance and Budget, and declaring an emergency.**

11 WHEREAS, on November 5, 2013, Summit County voters approved Issue 3, a renewal
12 tax levy for the purpose of operating and capital expenses for the provision and maintenance of
13 zoological park services and facilities at the Akron Zoo at a rate not exceeding eight-tenths (0.8)
14 mill for each one dollar of valuation, which amounts to eight cents (\$0.08) for each one hundred
15 dollars of valuation, for a period of seven years, beginning on the tax list and duplicate for the
16 year 2014, the proceeds of which would be first distributed to the County in 2015; and

18 WHEREAS, it is necessary to appropriate said tax levy funds, in the amount of the
19 \$8,562,984.00, from said tax levy for tax year 2015/collection year 2016; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
22 that it is necessary and in the best interest of the County of Summit to appropriate funds, in the
23 amount of \$8,562,984.00, from a tax levy for the Akron Zoological Park for tax year
24 2015/collection year 2016;

26 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
27 of Ohio, that:
