12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
13 requires this Council's authorization for the County Executive to advertise for bids; and

15 WHEREAS, the County Executive wishes to advertise for bids for the Children Services
16 Administration Building Roof Replacement Project, at 264 S. Arlington Street, Akron, Ohio
17 44306, in Council District 4, for an estimated total cost not to exceed \$240,000.00; and

19 WHEREAS, a copy of the bid specifications are attached as Exhibit A; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
22 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
23 advertise for bids for the Children Services Administration Building Roof Replacement Project,
24 for an estimated total cost not to exceed \$240,000.00;

31 The County Executive is authorized to advertise for bids for the Children Services
32 Administration Building Roof Replacement Project, at 264 S. Arlington Street, Akron, Ohio
33 44306, in Council District 4, for an estimated total cost not to exceed \$240,000.00.

37 This Resolution is declared an emergency in the interest of the health, safety, and welfare
38 of the citizens of the County of Summit, and for the further reason that it authorizes the
39 Executive to immediately advertise for bids for the Children Services Administration Building
40 Roof Replacement Project, for an estimated cost not to exceed \$240,000.00.

44 Provided this Resolution receives the affirmative vote of eight members, it shall take
45 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
46 effect and be in force at the earliest time provided by law.




