SECTION 2

Membership on the Healthier Buckeye Council shall consist of and be limited to the members of the Summit County Social Services Advisory Board's ("SSAB") Executive Committee and Health and Human Services Committee. As the membership of the aforementioned SSAB committees may change from time to time, the membership of the Summit County Healthier Buckeye Council shall concurrently change.

SECTION 3

The Health Commissioner of the Summit County Combined General Health District ("Health District"), who is also a member of the SSAB Executive Committee, or his/her designee(s) from among the Health District staff shall serve as the staffing agent for the Summit County Healthier Buckeye Council.

SECTION 4

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit, and for the further purpose of immediately establishing the Summit County Healthier Buckeye Council to apply for funds under the Healthier Buckeye Pilot Program.

SECTION 5

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

SECTION 6

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
