7 **A Resolution confirming an award by the Board of Control of a purchase contract to**  
8 **JoMac, Ltd., for two utility construction service bodies and two truck mounted service**  
9 **cranes to be installed on a 2015 Ford F-550 and a 2016 Ford F-550, in an amount not to**  
10 **exceed \$80,030.08, for the Executive's Department of Sanitary Sewer Services, and**  
11 **declaring an emergency.**

13 WHEREAS, this Council previously adopted Resolution No. 2016-052, which authorized  
14 the County Executive to advertise for bids for the purchase of two utility construction service  
15 bodies and a truck mounted service crane to be installed on a 2015 Ford F-550 and 2016 Ford F-  
16 550, for an estimated cost not to exceed \$76,514.00; and

17  
18 WHEREAS, the Board of Control, at its meeting held April 13, 2016, awarded a purchase  
19 contract to JoMac, Ltd., for two utility construction service bodies and two truck mounted  
20 service cranes to be installed on a 2015 Ford F-550 and a 2016 Ford F-550, in an amount not to  
21 exceed \$80,030.08, subject to confirmation by County Council; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information  
24 that the aforementioned purchase contract with JoMac, Ltd. is necessary and in the best interest  
25 of the County of Summit;

27 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
28 of Ohio, that:

30 SECTION 1

32 The award by the Board of Control of a purchase contract to JoMac, Ltd. for two utility  
33 construction service bodies and two truck mounted service cranes to be installed on a 2015 Ford  
34 F-550 and a 2016 Ford F-550, is hereby confirmed and the County Executive is hereby  
35 authorized to execute such purchase contract.

37 SECTION 2

39 This Resolution is hereby declared an emergency in the interest of health, safety and  
40 welfare of the citizens of the County of Summit, and for the further reason to immediately  
41 provide for the necessary components to maintain Department of Sanitary Sewer System  
42 vehicles in good operational condition through 2016.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take  
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
48 effect and be in force at the earliest time provided by law.
