7 **A Resolution appropriating funds for Indigent Driver Alcohol Treatment, in the amount of**
8 **\$30,000.00, for the Court of Common Pleas-Juvenile Division, and declaring an emergency.**

10 WHEREAS, the County has formed the Indigent Driver Alcohol Treatment fund
11 (“IDAT”) pursuant to Section 4511.191(H)(1) of the Ohio Revised Code; and

13 WHEREAS, the fund can only be used to provide mandatory substance abuse treatment
14 for indigent OVI offenders and indigent juvenile traffic offenders who have a diagnosis of
15 alcohol or drug abuse/dependence; and

17 WHEREAS, this Council finds and determines after reviewing all pertinent information
18 that the aforementioned appropriations are necessary and in the best interest of the County of
19 Summit;

21 NOW THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State
