The view will start on Dorwick Drive between Kenwick Drive and Pickwick Drive from 2:00 pm to 2:45 pm. The view will then continue from 3:00 pm until 4:00 pm at the Northfield Center Township Town Hall located at 9546 Brandywine Road, Northfield Center, Ohio 44067. A Public Hearing will take place on Monday, June 20, 2016 at 4:30 pm in Council Chambers, Ohio Building – 7th Floor, 175 South Main Street, Akron, Ohio.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit and for the further reason to immediately authorize the publication and notice of a viewing and hearing for a proposed public improvement located in Northfield Center Township, Summit County, Ohio.
