7 **A Resolution authorizing the County Executive to execute an Ohio Public Works**  
8 **Commission grant application and any other documents necessary to apply for and accept**  
9 **Local Transportation Improvement Program grant funds, in the amount of \$370,000.00,**  
10 **with no local cash match requirement, for the resurfacing of Killian Road from South**  
11 **Main Street to West of South Arlington Road, in Coventry Township, for the Engineer,**  
12 **and declaring an emergency.**

13  
14 WHEREAS, the County Engineer concludes that there is a public need for the resurfacing  
15 of Killian Road from South Main Street to West of South Arlington Road in Coventry Township,  
16 in Council District 8, and

17  
18 WHEREAS, the County of Summit is eligible to acquire Ohio Public Works Commission  
19 Local Transportation Improvement Program ("LTIP") grant funds, in the amount of  
20 \$370,000.00, with no local cash match requirement, for the resurfacing of Killian Road from  
21 South Main Street to West of South Arlington Road, in Coventry Township, in Council District  
22 8; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
25 that it is necessary and in the best interest of the County of Summit to authorize the County  
26 Executive to execute an Ohio Public Works Commission grant application and any other  
27 documents necessary to apply for and accept LTIP grant funds for the aforementioned purpose;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
30 of Ohio, that:

32 SECTION 1

33  
34 The County Executive is hereby authorized to execute an Ohio Public Works grant  
35 application and to execute any other documents necessary to accept and administer a grant for  
36 Ohio Public Works Commission Local Transportation Improvement Program ("LTIP") funds,  
37 for the purpose of resurfacing of Killian Road from South Main Street to West of South  
38 Arlington Road in Coventry Township, in County Council District 8, (the "Project").

40 SECTION 2

41  
42 The terms of said application shall request 100% of the cost of the Project from the Ohio  
43 Public Works Commission.

45 SECTION 3

46  
47 The County Executive is authorized to execute said grant application necessary to apply  
48 for the aforementioned grant funds only for the Ohio Public Works Program Year 31, with  
49 further authorization required for any future grant applications for the purpose of resurfacing of  
50 Killian Road.

6 The Clerk of Council is instructed to provide two certified copies of this Resolution to the  
7 County Engineer, for submission to the Ohio Public Works Commission with said grant  
8 application.

10 SECTION 5

12 This Resolution is hereby declared an emergency in the interest of the health, safety and  
13 welfare of the citizens of the County of Summit, and for the further reason that it will allow the  
14 County to obtain grant funds for an immediately needed resurfacing project.

16 SECTION 6

17  
18 Provided this Resolution receives the affirmative vote of eight members, it shall take  
19 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
20 effect and be in force at the earliest time provided by law.

22 SECTION 7

24 It is found and determined that all formal actions of this Council concerning and relating  
25 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
26 deliberations of this Council and of any of its committees that resulted in such formal action,  
27 were in meetings open to the public, in compliance with all legal requirements, including Section  
28 121.22 of the Ohio Revised Code.
