14 service contracts with certain providers for the State Fiscal Year 2017 Temporary Assistance to
15 Needy Families/Comprehensive Case Management Employment Program, for the period 7/1/16
16 through 6/30/17, in a total amount not to exceed \$1,028,000.00; and

21 that the aforementioned professional service contracts with certain providers are necessary and in

32 Case Management Employment Program, for the period 7/1/16 through 6/30/17, in a total
33 amount not to exceed \$1,028,000.00, , is hereby authorized and the County Executive is hereby
34 authorized to execute the aforementioned professional services contracts.

38 This Resolution is hereby declared an emergency in the interest of the health, safety and
39 welfare of the citizens of the County of Summit, and for the further reason to immediately
40 provide for the State Fiscal Year 2017 Temporary Assistance to Needy Families/Comprehensive
