11 **Juvenile Division, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held June 15, 2016, awarded a
14 professional service contract to the Summit County Combined General Health District dba
15 Summit County Public Health, for substance abuse screening and counseling services, for the
16 period 7/1/16 through 6/30/17, in an amount not to exceed \$55,346.00, subject to confirmation
17 by County Council; and

19 WHEREAS, this Council finds and determines after reviewing all pertinent information,
20 that the aforementioned professional service contract with the Summit County Combined
21 General Health District dba Summit County Public Health is necessary and in the best interest of
22 the County of Summit;

24 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

29 The award by the Board of Control of a professional service contract with the Summit
30 County Combined General Health District dba Summit County Public Health, for substance
31 abuse screening and counseling services, for the period 7/1/16 through 6/30/17, in an amount not
32 to exceed \$55,346.00 is hereby confirmed and the County Executive is hereby authorized to
33 execute such professional service contract.

37 This Resolution is hereby declared an emergency in the interest of the health, safety and
38 welfare of the citizens of the County of Summit, and for the further reason to immediately
39 provide for substance abuse screening and counseling services effective 7/1/16.

44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
45 effect and be in force at the earliest time provided by law.
