WHEREAS, on November 27, 2015 Dr. Dorothy Dean resigned from the Medical Examiner's Office, leaving one of the three Medical Examiner positions vacant; and

WHEREAS, the County has sought a replacement for the vacant Deputy Medical Examiner position since Dr. Dean's resignation, but has been unable to fill the position with a qualified candidate; and

WHEREAS, the Board of Control at a meeting on July 27, 2016, approved a contract with Cejka Search, Inc., a Cross Country Healthcare Company, not to exceed \$28,000.00, to help conduct a search to fill Dr. Dorothy Dean's former position as Deputy Medical Examiner; and

WHEREAS, the Board of Control at a meeting on July 27, 2016 also approved a contract with Erica J. Armstrong, M.D., not to exceed \$1,000.00 per autopsy, to perform autopsies as an individual contractor for the Medical Examiner's Office; and

WHEREAS, the current opiate epidemic within the County has created an increased case load and backlog of cases, necessitating the aforementioned contracts; and

WHEREAS, the Medical Examiner's Office has \$78,000.00 in available salary appropriation as a result of the previously mentioned vacancy and desires to move these appropriations to contract services to fund the aforementioned contracts;

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to appropriate said funds in the amount of \$78,000.00;
