7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept a State Fiscal Year 2015 RECLAIM Ohio Grant, in the estimated amount of**
9 **\$4,703,034.50, with no local cash match requirement, from the Ohio Department of Youth**
10 **Services, for the period 7/1/14 through 6/30/15, and appropriating \$4,703,034.50 in state**
11 **funding for expenditures through 12/31/14, for the Court of Common Pleas - Juvenile**
12 **Division, and declaring an emergency.**

14 WHEREAS, RECLAIM Ohio is an initiative developed in 1993 to address the State's
15 overburdened juvenile justice system and allows local courts to target specific areas to help
16 divert youth from being institutionalized; and

18 WHEREAS, the Court of Common Pleas – Juvenile Division has been awarded a State
19 Fiscal Year (“SFY”) 2015 RECLAIM Ohio Grant (Juvenile Delinquent Care and Custody) from
20 the Ohio Department of Youth Services, which has estimated the annual award of \$4,703,034.50,
21 with no local cash match requirement, for the period 7/1/14 through 6/30/15; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
24 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
25 execute any documents necessary to accept the award of the aforementioned grant from the Ohio
26 Department of Youth Services and to appropriate grant funds;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
29 of Ohio, that:

33 The County Executive is hereby authorized to execute any documents necessary to accept
34 the State Fiscal Year (“SFY”) 2015 RECLAIM Ohio Grant award from the Ohio Department of
35 Youth Services, in the estimated amount of \$4,703,034.50, with no local cash match
