7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **purchase two collapse search and rescue vehicles for use by the Technical Rescue**
9 **Operations Team, subject to the approval of the Board of Control, with one vehicle to be**
10 **purchased from Copley Township in an amount not to exceed \$135,000.00, and one vehicle**
11 **to be purchased from the Village of Richfield in an amount not to exceed \$125,000.00, for a**
12 **total not to exceed amount of \$260,000.00, to be paid using Fiscal Year 2013 State**
13 **Homeland Security Grant Program funds, for the Executive's Department of Law,**
14 **Insurance and Risk Management - Division of Public Safety/Emergency Management**
15 **Agency, and declaring an emergency.**

17 WHEREAS, pursuant to Chapter 163 of the Codified Ordinances of the County of
18 Summit, the Special Operations Response Teams ("SORT") Executive Board was created to,
19 among other things, supervise the Technical Rescue Operations Team ("TROT") including
20 training and equipping the TROT; and

21
22 WHEREAS, this Council previously adopted Resolution No. 2014-181, which authorized
23 the County Executive to advertise for bids for two collapse search and rescue vehicles for use by
24 the TROT, for an estimated total cost not to exceed \$270,000.00, to be paid using Fiscal Year
25 2013 State Homeland Security Grant Program funds; and

27 WHEREAS, after reviewing the submitted bids, on June 9, 2014, the SORT Executive
28 Board approved the purchase of one collapse and search rescue vehicle from Copley Township
29 in an amount not to exceed \$135,000.00, and the purchase of one collapse search and vehicle
30 from the Village of Richfield in an amount not to exceed \$125,000.00, for a total not to exceed
31 amount of \$260,000.00; and

33 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
34 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
35 execute any documents necessary to purchase two collapse search and rescue vehicles for use by
36 the TROT, subject to the approval of the Board of Control, from Copley Township and the
37 Village of Richfield, for a total amount not to exceed \$260,000.00, to be paid using Fiscal Year
38 2013 State Homeland Security Grant Program funds;

40 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
41 of Ohio, that:

45 The County Executive is hereby authorized to execute any documents necessary to
46 purchase two collapse search and rescue vehicles from use by the Technical Rescue Operations
47 Team ("TROT"), subject to the approval of the Board of Control, with one vehicle to be
48 purchased from Copley Township in an amount not to exceed \$135,000.00, and one vehicle to be
49 purchased from the Village of Richfield in an amount not to exceed \$125,000.00, for a total not
50 to exceed amount of \$260,000.00, to be paid using Fiscal Year 2013 State Homeland Security
51 Grant Program funds.

6 This Resolution is hereby declared an emergency in the interest of the health, safety and
7 welfare of the citizens of the County of Summit and for the further purpose of immediately
8 authorizing the Executive to execute any documents necessary to purchase two collapse search
9 and rescue vehicles for use by the TROT, subject to the approval of the Board of Control, from
10 Copley Township and the Village of Richfield.

14 Provided this Resolution receives the affirmative vote of eight members, it shall take
15 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
16 effect and be in force at the earliest time provided by law.
