A Resolution authorizing the County Executive to execute any documents necessary to purchase two collapse search and rescue vehicles for use by the Technical Rescue Operations Team, subject to the approval of the Board of Control, with one vehicle to be purchased from Copley Township in an amount not to exceed \$135,000.00, and one vehicle to be purchased from the Village of Richfield in an amount not to exceed \$125,000.00, for a total not to exceed amount of \$260,000.00, to be paid using Fiscal Year 2013 State Homeland Security Grant Program funds, for the Executive's Department of Law, Insurance and Risk Management - Division of Public Safety/Emergency Management Agency, and declaring an emergency.

WHEREAS, pursuant to Chapter 163 of the Codified Ordinances of the County of Summit, the Special Operations Response Teams ("SORT") Executive Board was created to, among other things, supervise the Technical Rescue Operations Team ("TROT") including training and equipping the TROT; and

WHEREAS, this Council previously adopted Resolution No. 2014-181, which authorized the County Executive to advertise for bids for two collapse search and rescue vehicles for use by the TROT, for an estimated total cost not to exceed \$270,000.00, to be paid using Fiscal Year 2013 State Homeland Security Grant Program funds; and

WHEREAS, after reviewing the submitted bids, on June 9, 2014, the SORT Executive Board approved the purchase of one collapse and search rescue vehicle from Copley Township in an amount not to exceed \$135,000.00, and the purchase of one collapse search and vehicle from the Village of Richfield in an amount not to exceed \$125,000.00, for a total not to exceed amount of \$260,000.00; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute any documents necessary to purchase two collapse search and rescue vehicles for use by the TROT, subject to the approval of the Board of Control, from Copley Township and the Village of Richfield, for a total amount not to exceed \$260,000.00, to be paid using Fiscal Year 2013 State Homeland Security Grant Program funds;
