7 **A Resolution confirming an award by the Board of Control of professional service**
8 **contracts with providers per attached Exhibit A for behavioral health and juvenile justice**
9 **service provider contracts, for the period 7/1/14 through 6/30/15, in a total amount not to**
10 **exceed \$220,300.00, for the Court of Common Pleas – Juvenile Division, and declaring an**
11 **emergency.**

13 WHEREAS, the Board of Control, at its meeting held June 11, 2014, awarded
14 professional service contracts with providers per attached Exhibit A for behavioral health and
15 juvenile justice service provider contracts, for the period 7/1/14 through 6/30/15, subject to
16 confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the contracts are necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
22 of Ohio, that:

26 The award by the Board of Control of professional service contracts with providers per
27 attached Exhibit A for behavioral health and juvenile justice service provider contracts, for the
28 period 7/1/14 through 6/30/15, in a total amount not to exceed \$220,300.00, is hereby confirmed
29 and the County Executive is hereby authorized to execute such contracts.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 provide for behavioral health and juvenile justice service provider contracts effective 7/1/14.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.

46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
47 deliberations of this Council and of any of its committees that resulted in such formal action,




