WHEREAS, Bank of America has provided merchant services and bank card processing services to the Clerk of Courts Office for transactions from 3/1/08 through 4/30/14; and

WHEREAS, from 8/11/10 through 4/30/14, the County made payments to Bank of America in amount of \$59,559.43; and

WHEREAS, the County of Summit Court of Common Pleas, General Division has mandated, pursuant to Local Rule 7, that effective August 2014, all case filings shall be done electronically through the Clerk of Courts Office, which will vastly increase the amount of necessary merchant services and bank card processing services due to filing fees; and

WHEREAS, the County of Summit Court of Common Pleas—Domestic Division will similarly mandate electronic filing in January 2015; and

WHEREAS, the Clerk of Courts estimates that the cost for the necessary merchant services and bank card processing services could be as high as \$150,000.00 from 5/1/14 through 4/30/15; and

WHEREAS, the failure to renew the professional service contract with Bank of America would adversely affect the ability of Summit County citizens to pay fees, including filing fees, to the Clerk of Courts Office; and

WHEREAS, it is necessary to ratify, subject to the approval of the Board of Control, the professional service contract with Bank of America to provide merchant services and bank card processing services to the Clerk of Courts, for an initial term from 3/1/08 through 4/30/11 and three one year renewals, from 5/1/11 through 4/30/14; and

WHEREAS, it is further necessary to ratify the payments made by the County to Bank of America, subject to the approval of the Board of Control, in the amount of \$59,559.43, from 8/11/10 through 4/30/14; and

WHEREAS, it is further necessary to authorize a renewal (4th of 5) of the professional service contract with Bank of America, subject to the approval of the Board of Control, for an additional one-year term, from 5/1/14 through 4/30/15, for an amount not to exceed \$150,000.00; and

WHEREAS this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County to ratify the aforementioned professional service contract with Bank America for merchant services and bank card processing services for the Clerk of Courts, for an initial term from 3/1/08 through 4/30/11 and three one-year renewals, from 5/1/11 through 4/30/14, to ratify the payments made by the County to Bank of America in the amount of \$59,559.43, made from 8/11/10 through 4/30/14 and to authorize a renewal (4th of 5) of the contract with Bank of America for an additional one-year term, from 5/1/14 through 4/30/15, for an amount not to exceed \$150,000.00, all subject to the approval of the Board of Control;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

This Council hereby ratifies a professional service contract with Bank of America, N.A., subject to the approval of the Board of Control, to provide merchant services and bank card processing services to the Clerk of Courts, for an initial term from 3/1/08 through 4/30/11 and three one year renewals, from 5/1/11 through 4/30/14. The professional service contract and addendum are attached to this Resolution as Exhibit A and incorporated herein as if fully restated. This Council further ratifies the payments made by the County to Bank of America, N.A., subject to the approval of the Board of Control, in the amount of \$59,559.43, from 8/11/10 through 4/30/14.

SECTION 2
