7 **A Resolution confirming an award by the Board of Control of a purchase contract with RR**  
8 **Donnelley for the printing and mailing of the 2014 sexennial reappraisal value update**  
9 **notices, under National Joint Powers Alliance pricing, in an amount not to exceed**  
10 **\$96,206.00, for the Fiscal Officer, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held July 23, 2014, awarded a purchase  
13 contract for the printing and mailing of the 2014 sexennial reappraisal value update notices,  
14 under National Joint Powers Alliance pricing, subject to confirmation by County Council; and,

16 WHEREAS, County Council has determined by reviewing all pertinent information that  
17 the purchase contract is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

24 The award by the Board of Control of a purchase contract with RR Donnelley for the  
25 printing and mailing of the 2014 sexennial reappraisal value update notices, under National Joint  
26 Powers Alliance pricing, in an amount not to exceed \$96,206.00, is hereby confirmed and the  
27 County Executive is hereby authorized to execute such purchase contract.

31 This Resolution is hereby declared an emergency in the interest of the health, safety and  
32 welfare of the citizens of the County of Summit, and for the further reason to immediately  
33 provide the notices in 2014.

37 Provided this Resolution receives the affirmative vote of eight members, it shall take  
38 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
39 effect and be in force at the earliest time provided by law.

43 It is found and determined that all formal actions of this Council concerning and relating  
44 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
45 deliberations of this Council and of any of its committees that resulted in such formal action,

47 121.22 of the Ohio Revised Code.
