12 WHEREAS, the Board of Control, at its meeting held July 9, 2014, awarded Change
13 Order No. 2 to a professional service contract with Community Legal Aid Services, Inc., for
14 legal services, in an amount not to exceed \$15,000.00 (28% cumulative increase), subject to
15 confirmation by County Council; and

17 WHEREAS, this Council finds and determines, by reviewing all pertinent information,
18 that the change order is necessary and in the best interest of the County of Summit;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

25 The award by the Board of Control of Change Order No. 2 to a professional service
26 contract with Community Legal Aid Services, Inc., for legal services, in an amount not to exceed
27 \$15,000.00 (28% cumulative increase), is hereby confirmed and the County Executive is hereby
28 authorized to execute such change order.

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the citizens of the County of Summit, and for the further reason to immediately
34 provide legal services in 2014.

38 Provided this Resolution receives the affirmative vote of eight members, it shall take
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
40 effect and be in force at the earliest time provided by law.

45 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
46 deliberations of this Council and of any of its committees that resulted in such formal action,
