A Resolution authorizing the County Executive to execute agreements and extensions to existing agreements with various local employers for participation in the Subsidized Employment Program and reimbursement through the use of Temporary Assistance to Needy Families funds, for the period 10/1/14 through 9/30/15, in a total amount not to exceed \$150,000.00, for the Executive's Department of Job and Family Services, and declaring an emergency.

WHEREAS, this Council previously adopted Resolution No. 2013-482, which authorized the County Executive to execute agreements and extensions to existing agreements with various employers for participation in the Subsidized Employment Program and reimbursement through the use of Temporary Assistance for Needy Families ("TANF") funds, for the period 10/1/13 through 9/30/14, in a total amount not to exceed \$150,000.00; and

WHEREAS, following said approval, the County has entered into new SEP agreements and extensions to existing agreements with several employers whereby those employers will be reimbursed using TANF funds for expenses incurred due to newly hired employees; and

WHEREAS, it is necessary for the Executive to execute agreements and extensions to existing agreements with various local employers for participation in the SEP and reimbursement through the use of TANF funds, for the period 10/1/14 through 9/30/15, in a total amount not to exceed \$150,000.00,

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County to authorize the Executive to execute the aforementioned agreements and extensions to existing agreements with various employers for participation in the SEP and reimbursement through the use of TANF funds, for the period 10/1/14 through 9/30/15, in a total amount not to exceed \$150,000.00;

NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The County Executive is hereby authorized to execute agreements and extensions to existing agreements with various local employers for participation in the Subsidized Employment Program and reimbursement through the use of Temporary Assistance to Needy Families funds, for the period 10/1/14 through 9/30/15, in a total amount not to exceed \$150,000.00.

SECTION 2

This Resolution is hereby declared to be an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit and for the further reason that it is necessary to immediately authorize the Executive to execute the aforementioned SEP agreement and expend TANF funds for reimbursement as timely as possible during the grant period beginning on 10/1/14.
