7 **A Resolution authorizing the County Executive to advertise for bids for construction**
8 **contracts, to be funded by Community Development Block Grant funds, to connect income-**
9 **qualified residents who have failing septic systems and orders from Summit County Public**
10 **Health to public utilities, for an estimated total cost not to exceed \$125,000.00, for the**
11 **Executive's Department of Community and Economic Development, and declaring an**
12 **emergency.**

14 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
15 requires this Council's authorization for the County Executive to advertise for bids; and

16
17 WHEREAS, the County Executive wishes to advertise for bids for construction contracts,
18 to be funded by Community Development Block Grant funds, to connect income-qualified
19 residents who have failing septic systems and orders from Summit County Public Health; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
22 that is necessary and in the best interest of the County of Summit to authorize the Executive to
23 advertise for bids for construction contracts to connect income-qualified residents who have
24 failing septic systems and orders from Summit County Public Health;

26 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
27 of Ohio, that;

31 The County Executive is authorized to advertise for bids for construction contracts, to be
32 funded by Community Development Block Grant funds, to connect income-qualified residents
33 who have failing septic systems and orders from Summit County Public Health to public utilities,
34 for an estimated total cost not to exceed \$125,000.00.

38 This Resolution is declared an emergency in the interest of the health, safety, and welfare
39 of the citizens of the County of Summit, and for the further reason that it authorizes the
40 Executive to immediately advertise for bids for construction contracts, to be funded by
41 Community Development Block Grant funds, to connect income-qualified residents who have
42 failing septic systems and orders from Summit County Public Health to public utilities.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
48 effect and be in force at the earliest time provided by law.
