7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with Greenleaf Family Center to provide on-site case management services for**
9 **clients participating in the Summit County Occupational Preparation Experience program,**
10 **for the period 10/1/14 through 9/30/15, with two options to renew for a one-year period, in**
11 **an amount not to exceed \$68,569.00, for the Executive's Department of Job and Family**
12 **Services, and declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held October 1, 2014, awarded a
15 professional service contract with Greenleaf Family Center to provide on-site case management
16 services for clients participating in the Summit County Occupational Preparation Experience
17 program, for the period 10/1/14 through 9/30/15, with two options to renew for a one-year
18 period, subject to confirmation by County Council; and,

20 WHEREAS, County Council has determined by reviewing all pertinent information that
21 the contract is necessary and in the best interest of the County of Summit;

23 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

28 The award by the Board of Control of a professional service contract with Greenleaf
29 Family Center to provide on-site case management services for clients participating in the
30 Summit County Occupational Preparation Experience program, for the period 10/1/14 through
31 9/30/15, with two options to renew for a one-year period, in an amount not to exceed \$68,569.00,
32 is hereby confirmed and the County Executive is hereby authorized to execute such contract.

36 This Resolution is hereby declared an emergency in the interest of the health, safety and
37 welfare of the citizens of the County of Summit, and for the further reason to provide on-site
38 case management services effective 10/1/14.

42 Provided this Resolution receives the affirmative vote of eight members, it shall take
43 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
44 effect and be in force at the earliest time provided by law.
