7 **A Resolution confirming an award by the Board of Control of a renewal (first and only) of**
8 **a professional service contract with Greenleaf Family Center to assist two-parent**
9 **households in meeting mandated Ohio Works First work participation requirements, for**
10 **the period 10/1/14 through 9/30/15, in an amount not to exceed \$64,541.00, for the**
11 **Executive's Department of Job and Family Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held October 1, 2014, awarded a
14 renewal (first and only) of a professional service contract with Greenleaf Family Center to assist
15 two-parent households in meeting mandated Ohio Works First work participation requirements,
16 for the period 10/1/14 through 9/30/15, subject to confirmation by County Council; and,

18 WHEREAS, County Council has determined by reviewing all pertinent information that
19 the contract renewal is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

26 The award by the Board of Control of a renewal (first and only) of a professional service
27 contract with Greenleaf Family Center to assist two-parent households in meeting mandated
28 Ohio Works First work participation requirements, for the period 10/1/14 through 9/30/15, in an
29 amount not to exceed \$64,541.00, is hereby confirmed and the County Executive is hereby
30 authorized to execute such contract renewal.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit, and for the further reason to provide assistance
36 to two-parent households in meeting mandated Ohio Works First work participation
37 requirements effective 10/1/14.

41 Provided this Resolution receives the affirmative vote of eight members, it shall take
42 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
43 effect and be in force at the earliest time provided by law.

48 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all


