7 **A Resolution, pursuant to Section 177.13 of the Codified Ordinances of the County of**
8 **Summit, ratifying purchases by the County Clerk of Courts from GNG Solutions, LLC, in**
9 **calendar year 2014 for various sized envelopes required by the Clerk of Courts' Office, in**
10 **the aggregate amount of \$29,898.10, and authorizing additional purchases from GNG**
11 **Solutions, LLC, for additional envelopes, in an amount not to exceed \$20,101.90, for a total**
12 **aggregate amount not to exceed \$50,000.00, for calendar year 2014, for Clerk of Courts,**
13 **and declaring an emergency.**

14
15 WHEREAS, Section 177.13 of the Codified Ordinances of the County of Summit
16 requires that purchases by an officeholder exceeding \$25,000.00 in aggregate in any calendar
17 year, where no additional competitive quotes or bids have been taken, shall be made only upon
18 authorization of County Council; and

19
20 WHEREAS, the judicial procedures of the Clerk of Courts' Office require it to use
21 approximately 80,000 office envelopes annually; and

23 WHEREAS, the Executive's Department of Finance and Budget and the Board of
24 Control have previously approved purchases by the Clerk of Courts from GNG Solutions, LLC,
25 in calendar year 2014 for various sized envelopes required by the Clerk of Courts' Office, in the
26 aggregate amount of \$25,318.66; and

28 WHEREAS, there are four open purchase order balances for additional invoices from
29 GNG Solutions, LLC, for said purpose for calendar year 2014 totaling \$4,579.44, for a total
30 aggregate amount of \$29,898.10, that requires Council approval; and

32 WHEREAS, the Clerk of Courts anticipates that it will make additional purchases from
33 GNG Solutions, LLC, for additional envelopes, in an amount not to exceed \$20,101.90, for a
34 total aggregate amount not to exceed \$50,000.00, for calendar year 2014; and

36 WHEREAS this Council finds and determines, after reviewing all pertinent information,
37 that it is necessary and in the best interest of the County to ratify purchases by the County Clerk
38 of Courts from GNG Solutions, LLC, in calendar year 2014 for various sized envelopes required
39 by the Clerk of Courts' Office, in the aggregate amount of \$29,898.10, and authorizing
40 additional purchases from GNG Solutions, LLC, for additional envelopes, in an amount not to
41 exceed \$20,101.90, for a total aggregate amount not to exceed \$50,000.00, for calendar year
42 2014;

8 Courts' Office, in the aggregate amount of \$29,898.10, and authorizing additional purchases
9 from GNG Solutions, LLC, for additional envelopes, in an amount not to exceed \$20,101.90, for
10 a total aggregate amount not to exceed \$50,000.00, for calendar year 2014.

14 This Resolution is hereby declared an emergency in the interest of the health, safety and
15 welfare of the citizens of the County of Summit, and for the further reason to immediately
16 provide the necessary envelopes for the Clerk of Courts' Office in calendar year 2014.

20 Provided this Resolution receives the affirmative vote of eight members, it shall take
21 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
22 effect and be in force at the earliest time provided by law.

27 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
28 deliberations of this Council and of any of its committees that resulted in such formal action,
