SECTION 1

The County Executive is hereby authorized to execute a memorandum of agreement with the State of Ohio Department of Transportation ("ODOT") and the Eastern Federal Lands Highway Division ("EFL"), for the improvement of Boston Mills Road, located in Boston Township, Council District 1 ("Project").

SECTION 2

The terms of the memorandum of agreement shall include the following:

- a. That the parties estimate the Project's design and construction cost to be \$409,750.00, with said cost including construction engineering and inspection; and
- b. That the parties estimate the Project's total cost to be \$409,750.00; and
- c. That the net estimated cost to the County of Summit shall not to exceed \$109,750.00; and
- d. That the County of Summit shall provide all other financial resources necessary to fully complete the Project.

SECTION 3

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit, and for the further reason that it immediately completes a prerequisite needed in order to accept grant money awarded for a County road project in Boston Township.

SECTION 4

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.
