A Resolution authorizing the County Executive to execute a five-year agreement with Portage County Combined General Health District for backup plumbing inspection services, for the period 1/1/15 through 12/31/19, to be provided upon request by either county, in the amount of \$71.53 per hour plus mileage and business expenses, for the Executive's Department of Community and Economic Development – Building Standards Division, and declaring an emergency.

WHEREAS, both Summit County and Portage County are charged with the enforcement of plumbing rules and regulations and have employed certified plumbing inspectors; and

WHEREAS, both counties need part-time occasional certified plumbing inspectors to supplement full-time certified employees by reason of their employees being on sick leave or vacation; and

WHEREAS, it is most cost effective for each county to use neighboring agencies' personnel for backup plumbing inspection services; and

WHEREAS, Summit County and Portage County Combined General Health District have agreed to execute a five-year agreement for backup plumbing inspection services, for the period 1/1/15 through 12/31/19, to be provided upon request by either county, in the amount of \$71.53 per hour plus mileage and business expenses; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the County Executive to execute a five-year agreement with Portage County Combined General Health District for backup plumbing inspection services, for the period 1/1/15 through 12/31/19, to be provided upon request by either county, in the amount of \$71.53 per hour plus mileage and business expenses;

NOW, THEREFORE, IT IS HEREBY RESOLVED by the Council of the County of Summit, State of Ohio, that:

## **SECTION 1**

The County Executive is hereby authorized to execute a five-year agreement with Portage County Combined General Health District for backup plumbing inspection services, for the period 1/1/15 through 12/31/19, to be provided upon request by either county, in the amount of \$71.53 per hour plus mileage and business expenses.
