A Resolution authorizing the County Executive to execute a three-year policing contract with Twinsburg Township, in Council District 1, pursuant to which the County Sheriff will provide Twinsburg Township with 12,095.20 Sheriff's Deputy hours for the period 1/1/15 through 12/31/17, in exchange for payment by Twinsburg Township of the amount of \$897,293.45 for the first year, \$918,138.92 for the second year and \$938,393.46 for the third year, for a total amount of \$2,753,825.83 during the three-year term of the contract, for the Sheriff, and declaring an emergency.

WHEREAS, County Council previously adopted Resolution No. 2011-423, which authorized the County Executive to execute a three-year policing contract with Twinsburg Township, in Council District 1, pursuant to which the County Sheriff provided seven Sheriff's Deputies to Twinsburg Township for the period 1/1/12 through 12/31/14, in exchange for payment by Twinsburg Township of the amount of \$743,149.33 for the first year, \$751,696.67 for the second year and \$756,212.00 for the third year, in a total amount of \$2,251,058.00 during the three-year term of the contract; and

WHEREAS, Twinsburg Township has requested that the County of Summit enter into a new contract pursuant to which the Sheriff will provide Twinsburg Township with 12,095.20 deputy hours for the period 1/1/15 through 12/31/17; and

WHEREAS, Twinsburg Township has agreed to pay the County \$897,293.45 for the first year, \$918,138.92 for the second year and \$938,393.46 for the third year, for a total amount of \$2,753,825.83 during the three-year term of the contract; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that authorizing the Executive to execute the aforementioned contract is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that;
