SECTION 1

The Report on Staffing for calendar year 2015, which is attached hereto as amended Exhibit A and incorporated herein by reference, is hereby approved and adopted by this Council.

This Resolution is hereby declared to be an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit and for the further reason that it is necessary to immediately approve and adopt the Report on Staffing prior to the deadline established by the Codified Ordinances of the County of Summit.
