A Resolution authorizing the County Executive to execute a one-year policing contract with the County of Summit Public Health Adult Protective Services to provide two full-time Sheriff's detectives and two one-shift vehicles, for the period 10/1/14 through 9/30/15, for a total amount of \$212,622.66, for the Sheriff, and declaring an emergency.

WHEREAS, this is a new contract with County of Summit Public Health Adult Protective Services ("APS"), and APS is asking to enter into a policing contract with the Sheriff's Office to provide two full-time Sheriff's detectives for the period 10/1/14 through 9/30/15; and

WHEREAS, APS has requested that the County Executive execute a new agreement to provide two full-time Sheriff's detectives and two one-shift vehicles, for the period 10/1/14 through 9/30/15; and

WHEREAS, APS has agreed to pay the County the amount of \$17,718.56 per month, for a total of \$212,622.66, for the period 10/1/14 through 9/30/15; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned contract is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that;

## SECTION 1

DECOLUTION NO

The County Executive is hereby authorized to enter into a one-year policing contract with the County of Summit Public Health Adult Protective Services ("APS") to provide two full-time Sheriff's detectives and two one-shift vehicles, for the period 10/1/14 through 9/30/15, for a total amount of \$212,622.66.

## **SECTION 2**

This Resolution is hereby declared an emergency in the interest of the health, safety, and welfare of the citizens of the County of Summit and for the further purpose of immediately providing necessary policing to County of Summit Public Health APS effective 10/1/14.

## **SECTION 3**

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.
