7 **A Resolution accepting the Fact Finder's Report related to the collective bargaining**
8 **agreement between Ohio Council 8 and Local 1229 of the American Federation of State,**
9 **County and Municipal Employees, AFL-CIO (Medical Examiner's Unit) and the County**
10 **Executive, which recommends a 1.5% increase in pay retroactive to 4/1/14, a 2.0% increase**
11 **in pay for second year of the agreement, the period from 4/1/15 through 3/31/16, and a**
12 **2.25% increase in pay for the third year of the agreement, the period from 4/1/16 through**
13 **3/31/17, for the Executive, and declaring an emergency.**

15 WHEREAS, a Fact Finder's Report has been issued related to the collective bargaining
16 agreement between Ohio Council 8 and Local 1229 of the American Federation of State, County
17 and Municipal Employees, AFL-CIO (Medical Examiner's Unit) and the County Executive,
18 which recommends a 1.5% increase in pay retroactive to 4/1/14, a 2.0% increase in pay for
19 second year of the agreement, the period from 4/1/15 through 3/31/16, and a 2.25% increase in
20 pay for the third year of the agreement, the period from 4/1/16 through 3/31/17; and

22 WHEREAS, the County Executive recommends that this Council accept the Fact
23 Finder's Report; and

26 that it is necessary and in the best interest of the County of Summit to accept the aforementioned

34 This Council hereby accepts the Fact Finder's Report related to the collective bargaining
35 agreement between Ohio Council 8 and Local 1229 of the American Federation of State, County
36 and Municipal Employees, AFL-CIO (Medical Examiner's Unit) and the County Executive,
37 which recommends a 1.5% increase in pay retroactive to 4/1/14, a 2.0% increase in pay for
38 second year of the agreement, the period from 4/1/15 through 3/31/16, and a 2.25% increase in
39 pay for the third year of the agreement, the period from 4/1/16 through 3/31/17.

44 welfare of the citizens of the County of Summit and for the further purpose of providing a timely
45 acceptance of the aforementioned collective bargaining agreement.

50 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
