7 **A Resolution authorizing the Executive or designee, to execute or initiate, for a two-year**
8 **period, from 1/1/22 through 12/31/23, through the State of Ohio’s County Financial**
9 **Information System, the acceptance by the Executive’s Department of Job and Family**
10 **Services of inter-county transfers of surplus funds from other Ohio counties, and to release**
11 **surplus County of Summit funds to other Ohio counties in exchange for those accepted**
12 **funds, provided that the collective funds released in a given calendar year do not exceed the**
13 **collective funds accepted in that calendar year, for the Executive’s Department of Job and**
14 **Family Services, and declaring an emergency.**

15
16 WHEREAS, Section 5101:9-6-82 of the Ohio Administrative Code authorizes counties to
17 engage in inter-county transfers of surplus funds allocated to county family services agencies
18 (“CFSAs”) by the Ohio Department of Job and Family Services; and

19
20 WHEREAS, Section 5101:9-6-82(F) states that when two CFSAs agree to an inter-
21 county transfer of funding, each CFSA shall complete the inter-county transfer budget request in
22 the county finance information system (“CFIS”), which shall serve as the agreement between the
23 county directors involved in the transaction; and

25 WHEREAS, Section 5101:9-6-82(F)(3)(b) provides that a board of county
26 commissioners may assign authority to another party to serve as designee and therefore, grant
27 that party authority to submit an inter-county transfer budget request on behalf of a county for a
28 specific period of time; and

30 WHEREAS, Section 5101:9-6-82(F)(3)(b) requires a county to state the specific time
31 period for which the designee may submit inter-county transfer budget requests; and

33 WHEREAS, the Executive desires to obtain the authority of this Council for the
34 Executive, or the Summit County Department of Job and Family Services (“SCDJFS”) Director,
35 as her designee, to execute or initiate, for a two-year period, from 1/1/22 through 12/31/23,
36 through CFIS and any other necessary related documents, the acceptance of inter-county
37 transfers of surplus funds from other Ohio counties, and to release surplus County of Summit
38 funds to other Ohio counties, in exchange for those accepted funds, provided that the collective
39 funds released in a given calendar year do not exceed the collective funds accepted in that
40 calendar year; and

42 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
43 that it is necessary and in the best interest of the County of Summit to authorize the Executive, or
44 the SCDJFS Director as her designee, for a two-year period, from 1/1/22 through 12/31/23, to
45 execute or initiate through CFIS and any other necessary related documents, the acceptance of
46 inter-county transfers of surplus funds from other Ohio counties, and to release surplus County
47 of Summit funds to other Ohio counties, in exchange for those accepted funds, provided that the
48 collective funds released in a given calendar year do not exceed the collective amount accepted
49 in that calendar year;

4 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
5 of Ohio, that:

7 SECTION 1

8
9 The Executive, or the Executive's designee, as set forth in Section 2 of this Resolution, is
10 hereby authorized, for a two-year period, from 1/1/22 through 12/31/23, to execute or initiate,
11 through the State of Ohio's County Financial Information System, the acceptance by the County
12 Executive's Department of Job and Family Services of inter-county transfers of surplus funds
13 from other Ohio counties, and to release surplus County of Summit funds to other Ohio counties,
14 in exchange for those accepted funds, provided that the collective funds released in a given
15 calendar year do not exceed the collective funds accepted in that calendar year. Any release of
16 surplus County of Summit funds to other Ohio counties that exceeds the amount of accepted
17 funds in any calendar year shall require the approval of this Council.

19 SECTION 2

21 The Executive or the Summit County Department of Job and Family Services
22 ("SCDJFS") Director, as her designee, is hereby assigned as designee of the County to effectuate
23 the transfers authorized in Section 1 for the Executive's Department of Job and Family Services,
24 pursuant to Section 5101:9-6-82(F)(3)(b), for a two-year period, from 1/1/22 through 12/31/23.

26 SECTION 3

28 This Resolution is hereby declared an emergency in the interest of the health, safety and
29 welfare of the residents of the County of Summit and for the further reason to immediately
30 authorize the Executive or her designee, to execute or initiate inter-county transfers, and any
31 documents necessary, for SCDJFS to accept inter-county transfers of surplus funds from other
32 Ohio counties and to release inter-county transfers of surplus County funds.

34 SECTION 4

36 Provided this Resolution receives the affirmative vote of eight members, it shall take
37 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
38 effect and be in force at the earliest time

40 SECTION 5

42 It is found and determined that all formal actions of this Council concerning and relating
43 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
44 deliberations of this Council and of any of its committees that resulted in such formal action,
45 were in meetings open to the public, in compliance with all legal requirements, including Section
46 121.22 of the Ohio Revised Code.


