7 **A Resolution confirming the award by the Board of Control of a professional service**
8 **contract with AllOne Health Resources, Inc. to provide Employee Assistance Program**
9 **services, for the period 1/1/22 to 12/31/22, with two options to renew for an additional one-**
10 **year term, for a total amount not to exceed \$123,452.00, and authorizing said services to**
11 **also be provided to employees of political subdivisions that have executed an Employee**
12 **Assistance Program Participation Agreement with the County, for the Executive's**
13 **Department of Human Resources, and declaring an emergency.**

15 WHEREAS, after posting on the County's purchasing website a request for proposals to
16 provide Employee Assistance Program ("EAP") services to County employees and employees of
17 other participating political subdivisions, to which three vendors submitted proposals, the
18 Executive selected AllOne Health Resources, Inc., as the most qualified vendor to provide said
19 EAP services; and

21 WHEREAS, the Executive wishes to execute a professional service contract with AllOne
22 Health Resources, Inc. for EAP services for County employees for the period 1/1/22 through
23 12/31/22, with two options to renew for an additional one-year term, for an amount not to exceed
24 \$16.00 per employee per year, for a total amount not to exceed \$123,452.00, and to provide other
25 political subdivisions EAP services under the professional service contract with AllOne Health
26 Resources, Inc. for their employees, that have executed an Employee Assistance Program
27 Participation Agreement with the County, subject to confirmation by this Council; and

29 WHEREAS, it is further necessary for this Council to authorize that the EAP services
30 provided to County employees pursuant to the aforementioned professional service contract with
31 AllOne Health Resources, Inc. shall also be provided to employees of political subdivisions that
32 have executed an Employee Assistance Program Participation Agreement with the County; and

34 WHEREAS, the Board of Control, at its meeting held January 5, 2022, awarded a
35 professional service contract with AllOne Health Resources, Inc. for EAP services for County
36 employees for the period 1/1/22 through 12/31/22, with two options to renew for an additional
37 one-year term, for an amount not to exceed \$16.00 per employee per year, for a total amount not
38 to exceed \$123,452.00, and to provide other political subdivisions EAP services under the
39 professional service contract with AllOne Health Resources, Inc. for their employees, that have
40 executed an Employee Assistance Program Participation Agreement with the County, subject to
41 confirmation by this Council; and

43 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
44 that the aforementioned professional service contract with AllOne Health Resources, Inc. to
45 provide EAP services is necessary and in the best interest of the County of Summit and it is
46 necessary and in the best interest of the County of Summit to authorize said EAP services to also
47 be provided to employees of political subdivisions that have executed an Employee Assistance
48 Program Participation Agreement with the County;

50 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
51 of Ohio, that:

4 SECTION 1

6 The award by the Board of Control of a professional service contract with AllOne Health
7 Resources, Inc. for Employee Assistance Program (“EAP”) services for County employees and
8 employees of other participating political subdivisions, for the period 1/1/22 through 12/31/22,
9 with two options to renew for an additional one-year term, for an amount not to exceed \$16.00
10 per employee per year, for a total amount not to exceed \$123,452.00, is hereby confirmed and
11 the Executive is hereby authorized to execute said professional service contract and any other
12 necessary related documents.

14 SECTION 2

16 This Council hereby authorizes EAP services provided to County employees pursuant to
17 the aforementioned professional service contract with AllOne Health Resources, Inc. to also be
18 provided to employees of political subdivisions that have executed an Employee Assistance
19 Program Participation Agreement with the County.

21 SECTION 3

23 This Resolution is hereby declared an emergency in the interest of the health, safety and
24 welfare of the residents of the County of Summit, and for the further reason of immediately
25 authorizing EAP services to be provided to County employees and employees of political
26 subdivisions that have executed an Employee Assistance Program Participation Agreement with
27 the County effective 1/1/22.

29 SECTION 4

31 Provided this Resolution receives the affirmative vote of eight members, it shall take
32 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
33 effect and be in force at the earliest time provided by law.

37 It is found and determined that all formal actions of this Council concerning and relating
38 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
39 deliberations of this Council and of any of its committees that resulted in such formal action,
40 were in meetings open to the public, in compliance with all legal requirements, including Section
41 121.22 of the Ohio Revised Code.


