7 **A Resolution confirming the award by the Board of Control of a purchase contract with**
8 **Cargill, Incorporated, at CUE pricing, for road salt for the 2022 snow and ice control**
9 **season, in an amount not to exceed \$700,000.00, for the Engineer, and declaring an**
10 **emergency.**

12 WHEREAS, it is necessary for the Engineer to purchase road salt as needed for snow and
13 ice control on County roadways for the remaining 2022 snow and ice control season and, as
14 such, the Engineer's Office budgets annually for the purchase of road salt; and

15
16 WHEREAS, the Board of Control, at its meeting held on January 19, 2022, awarded a
17 purchase contract to Cargill, Incorporated, at CUE pricing, for road salt for the 2022 snow and
18 ice control season, in an amount not to exceed \$700,000.00, subject to confirmation by this
19 Council; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
22 that the aforementioned purchase contract with Cargill, Incorporated is necessary and in the best
23 interest of the County of Summit;

25 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
26 of Ohio, that:

30 The award by the Board of Control of a purchase contract with Cargill, Incorporated, at
31 CUE pricing, for road salt for the 2022 snow and ice control season, in an amount not to exceed
32 \$700,000.00, is hereby confirmed and the Executive is hereby authorized to execute said
33 purchase contract and any other necessary related documents.

35 SECTION 2

37 This Resolution is hereby declared an emergency in the interest of the health, safety and
38 welfare of the residents of the County of Summit, and for the further reason to immediately
39 provide for road salt for the 2022 snow and ice control season.

43 Provided this Resolution receives the affirmative vote of eight members, it shall take
44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
45 effect and be in force at the earliest time provided by law.

10 121.22 of the Ohio Revised Code.


