WHEREAS, Black & Veatch and their subcontractor, O.R. Colan Associates, on behalf of the Executive's Department of Sanitary Sewer Services, have determined and negotiated the amount of a temporary easement for Parcel No. 5613382 which is real property owned by the State of Ohio, a copy of which is attached to this Resolution as Exhibit A, and incorporated herein as if fully restated, now being presented for approval, in an amount not to exceed \$7,460.00; and

WHEREAS, this Council has determined, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute the aforementioned agreement for the acquisition of a temporary easement;
