#### SECTION 1

The subdivision, which shall be known as "The Meadows of Wintergreen Phase III," located in Springfield Township, in Council District 8, together with restrictions, covenants and easements thereon, is hereby approved and accepted by the County of Summit, to be recorded by the Fiscal Officer.

#### **SECTION 2**

The following maintenance bond furnished by <u>Western Surety Company</u>, in the total amount of <u>\$ 75,837.00</u>, having been submitted and approved, was accepted in conjunction with "The Meadows of Wintergreen Phase III,". The documents are to be retained by the Executive, who is authorized to release said bond, in part or in full, upon satisfactory completion of the obligations set forth.

## **SECTION 3**

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the residents of the County of Summit, and for the further reason that it immediately facilitates development in Springfield Township, in Council District 8.

# **SECTION 4**

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.
