A Resolution ratifying the Executive's execution of a renewal (first and only) of a lease with Cleveland Clinic Akron General Medical Center for approximately 24.7 acres of land located at 1596 and 1621 Flickinger Rd., Akron Ohio 44312, in Council District 8, for a five-year term, for rent in the total amount of \$1.00 per year, for the Executive, and declaring an emergency.

WHEREAS, this Council previously adopted Resolution No. 2016-060 which authorized the Executive to enter into a five-year lease with the Akron General Medical Center for approximately 24.7 acres of County real property, being 18.84 acres of Parcel No. 5401864 and all of Parcel No. 5401992, located at 1596 and 1621 Flickinger Rd., Akron, Ohio, 44312, in Council District 8, for use as a golf course, driving range, pro shop and clubhouse, from 1/1/16 through 12/31/20, for rent of \$1.00 per year with one option to renew for an additional five-year term (the "Lease"); and

WHEREAS, the golf course, driving range, pro shop and clubhouse are utilized by the Akron General Medical Center, now the Cleveland Clinic Akron General Medical Center, to provide therapeutic benefits to persons with disabilities; and
