A Resolution authorizing the Executive to execute a partial release of a sanitary sewer easement originally granted in a plat for New Seasons Phase Two, Parcel No. 2816780 recorded in Reception No. 56679751 of the Records of the County of Summit, Ohio, located in the City of Green, in Council District 8, for the Executive's Department of Sanitary Sewer Services, and declaring an emergency.

WHEREAS, New Seasons Phase Two is a residential development located in the City of Green, in Council District 8, to be built by New Seasons JV, LLC (the "Developer"); and
