SECTION 2

Owners of parcels within the Glencairn Forest Phase X shall be assessed for drainage maintenance, proportional to the estimated benefit to the respective parcel, as set forth in the revised special assessment worksheet, a copy of which is attached hereto as Exhibit A and incorporated fully herein.

SECTION 3

Pursuant to Section 6137.03 of the Ohio Revised Code, the Clerk of Council shall certify the attached assessments to the Fiscal Officer for placement on the next succeeding tax duplicate to be collected and paid.

SECTION 4

This Resolution is hereby declared an emergency in the interest of the health, safety, and welfare of the residents of the County of Summit, and for the further reason to immediately fund necessary drainage maintenance in Glencairn Forest Phase X in Richfield Township, in Council District 1.

SECTION 5

Provided this resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

SECTION 6
