A Resolution authorizing the Executive to execute a Facility Use Agreement on behalf of the Sheriff, with the Coventry Township Trustees for a Watch Office to be located in the Coventry Township Hall, in Council District 8, for a three-year term, from 5/1/22 through 8/1/25, at no cost, for the Executive and Sheriff, and declaring an emergency.

WHEREAS, the Coventry Township Trustees have an agreement with the Sheriff for policing services in Coventry Township and have offered to the Sheriff space in the Coventry Township Hall for the purpose of maintaining a Watch Office at no cost to the Sheriff; and

WHEREAS, the Sheriff and the Trustees wish to have a Facility Use Agreement ("Agreement") in place to describe the Sheriff's use of said space; and

WHEREAS, the Agreement will be in effect from 5/1/22 through 4/30/25, and will provide that the Sheriff may make modifications to the premises at the Sheriff's expense; and

WHEREAS, this Agreement is exempt from Board of Control approval under section 177.21(a)(3) of the Codified Ordinances of the County of Summit as it is an intergovernmental agreement between the County and another political subdivision; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County to authorize the Executive to execute the aforementioned Agreement;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
