7 **A Resolution authorizing the Executive to execute a Facility Use Agreement on behalf of**
8 **the Sheriff, with the Coventry Township Trustees for a Watch Office to be located in the**
9 **Coventry Township Hall, in Council District 8, for a three-year term, from 5/1/22 through**
10 **8/1/25, at no cost, for the Executive and Sheriff, and declaring an emergency.**

12 WHEREAS, the Coventry Township Trustees have an agreement with the Sheriff for
13 policing services in Coventry Township and have offered to the Sheriff space in the Coventry
14 Township Hall for the purpose of maintaining a Watch Office at no cost to the Sheriff; and

15
16 WHEREAS, the Sheriff and the Trustees wish to have a Facility Use Agreement
17 (“Agreement”) in place to describe the Sheriff’s use of said space; and

18
19 WHEREAS, the Agreement will be in effect from 5/1/22 through 4/30/25, and will
20 provide that the Sheriff may make modifications to the premises at the Sheriff’s expense; and

22 WHEREAS, this Agreement is exempt from Board of Control approval under section
23 177.21(a)(3) of the Codified Ordinances of the County of Summit as it is an intergovernmental
24 agreement between the County and another political subdivision; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
27 that it is necessary and in the best interest of the County to authorize the Executive to execute the
28 aforementioned Agreement;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
31 of Ohio, that:

33 SECTION 1

35 The Executive is hereby authorized to enter into a Facility Use Agreement, on behalf of
36 the Sheriff, with the Coventry Township Trustees for use of space in the Coventry Township
37 Hall, in Council District 8, as a Watch Office, at no cost to the Sheriff, for a period from 5/1/22
38 through 4/30/25.

40 SECTION 2

42 This Resolution is hereby declared an emergency in the interest of the health, safety and
43 welfare of the residents of the County of Summit, and for the further reason to immediately
44 enable the Sheriff to establish a Watch Office in Coventry Township.

46 SECTION 3

48 Provided this Resolution receives the affirmative vote of eight members, it shall take
49 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
50 effect and be in force at the earliest time provided by law.
