7 **A Resolution authorizing the Executive to execute a renewal (second and final) of a One-**
8 **Stop Operator Services contract with the Summit and Medina Workforce Area Council of**
9 **Governments, pursuant to which the Executive's Department of Job and Family Services**
10 **will provide One-Stop Operator services at the Ohio Means Jobs Summit County Center,**
11 **for a one-year term, from 7/1/22 to 6/30/23, for which the County shall be paid an amount**
12 **not to exceed \$230,000.00, for the Executive's Department of Job and Family Services, and**
13 **declaring an emergency.**

14
15 WHEREAS, the U.S. Department of Labor's Employment and Training Administration
16 funds a network of American Job Centers ("AJCs") to provide free employment assistance to job
17 seekers at AJC network locations across the United States; and

18
19 WHEREAS, pursuant to the requirements of Workforce Innovation and Opportunity Act
20 of 2014 (the "WIOA") Section 121(d)(2)(A), Local Workforce Areas must competitively procure
21 the Operators of AJCs; and

22
23 WHEREAS, pursuant to requirements of WIOA, and on the behalf of the
24 Summit/Medina Workforce Development Board (the "WDB"), the Summit and Medina
25 Workforce Area Council of Governments (the "SAMWA COG"), which serves as the Ohio
26 Workforce Area 2 ("Area 2") staff, completed a competitive process to procure Operators for the
27 Area's AJCs, known in the State of Ohio as Ohio Means Jobs Centers, and in Summit County as
28 the Ohio Means Jobs Summit County Center, and in Medina County as the Ohio Means Jobs
29 Medina County Center; and

30
31 WHEREAS, this Council previously adopted Resolution No. 2016-326 authorizing the
32 Executive to execute an intergovernmental agreement with Medina County to create the Summit
33 and Medina Workforce Area Council of Governments, to execute bylaws for said council of
34 governments and to execute a Local Governance Agreement for Local Workforce Development
35 Area 2; and

37 WHEREAS, this Council subsequently adopted Resolution 2020-260 authorizing the
38 Executive to execute a One-Stop Operator Services contract with the SAMWA COG pursuant to
39 which DJFS will provide One-Stop Operator services at the Ohio Means Jobs Summit County
40 Center, for a one year term, from 7/1/20 through 6/30/21, with two options to renew for an
41 additional one-year term, for which the County shall be paid an amount not to exceed
42 \$228,109.71; and

44 WHEREAS, this Council approved the first renewal of this contract in Resolution 2021-
45 136; and

46
47 WHEREAS, the Executive wishes to execute a renewal (second and final) of a One-Stop
48 Operator Services contract with the SAMWA COG, pursuant to which DJFS will provide One-
49 Stop Operator Services at the Ohio Means Jobs Summit County Center, for the period 7/1/22
50 through 6/30/23, for which the County shall be paid an amount not to exceed \$230,000.00,
51 subject to confirmation by this Council; and

4 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
5 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
6 execute a renewal (second and final) of the One-Stop Operator Services contract with the
7 SAMWA COG, pursuant to which DJFS will provide One-Stop Operator services at the Ohio
8 Means Jobs Summit County Center, for the period 7/1/22 to 6/30/23, for which the County shall
9 be paid an amount not to exceed \$230,000.00; and

10
11 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
12 of Ohio, that:

14 SECTION 1

15
16 The Executive is hereby authorized to execute a renewal (second and final) of the One-
17 Stop Operator Services contract and any other necessary related documents with the Summit and
18 Medina Workforce Area Council of Governments (“SAMWA COG”), pursuant to which the
19 Executive’s Department of Job and Family Services (“DJFS”) will provide One-Stop Operator
20 services at the Ohio Means Jobs Summit County Center, for a one year term, from 7/1/22
21 through 6/30/23, for which the County shall be paid an amount not to exceed \$230,000.00.

23 SECTION 2

24
25 This Resolution is hereby declared an emergency in the interest of the health, safety and
26 welfare of the residents of the County of Summit, and for the further reason to immediately
27 authorize the Executive to execute a necessary One-Stop Operator Services contract with the
28 SAMWA COG, so that DJFS may immediately provide said services at the Ohio Means Jobs
29 Summit County Center.

31 SECTION 3

32
33 Provided this Resolution receives the affirmative vote of eight members, it shall take
34 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
35 effect and be in force at the earliest time provided by law.

37 SECTION 4

39 It is found and determined that all formal actions of this Council concerning and relating
40 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
41 deliberations of this Council and of any of its committees that resulted in such formal action,
42 were in meetings open to the public, in compliance with all legal requirements, including Section
43 121.22 of the Ohio Revised Code.
