Summit County Public Health, the County of Summit Alcohol, Drug Addiction and Mental Health Services Board, Summit County Developmental Disabilities Board and the Adult Guardianship Services of Summit County, for the operation of the Volunteer Guardian Program, for a one-year term, from 4/1/22 through 3/31/23, in an amount not to exceed \$357,000.00, with the Executive's Department of Job and Family Services' share not to exceed \$100,000.00, for the Executive's Department of Job and Family Services, and declaring an emergency.

WHEREAS, the Executive's Department of Job and Family Services seeks to enter into an intergovernmental agreement with the Summit County Combined General Health District d.b.a. Summit County Public Health ("SCPH"), the Summit County Alcohol, Drug Addiction and Mental Health Board, the Summit County Developmental Disabilities Board and the Adult Guardianship Services of Summit County, for the operation of the Volunteer Guardian Program by SCPH; and

WHEREAS, the Volunteer Guardian Program is a collaborative effort between the aforementioned entities, with SCPH acting as the fiscal agent and program administrator; and

WHEREAS, the Volunteer Guardian Program recruits, screens and trains guardians to serve as advocates and surrogate decision makers for wards of the Court of Common Pleas-Probate Division and assist in decision making regarding health care, housing, transportation, personal care necessities and options for their wards, as well as attend care conferences and court proceedings; and

WHEREAS, pursuant to Section 177.07(a)(2) of the Codified Ordinances of the County of Summit, this intergovernmental agreement is exempt from competitive bidding as it is an agreement with other governmental units; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information that the aforementioned intergovernmental agreement with various County entities for the Volunteer Guardian Program is necessary and in the best interest of the County of Summit;
