7 **A Resolution confirming the award by the Board of Control of a professional service**  
8 **contract with Sustainable Streams, LLC, as a Best Practical Source, to develop the Idle**  
9 **Brook Bankfull Wetlands Project for the Summit County Surface Water Management**  
10 **District, in an amount not to exceed \$88,500.00, for the Engineer, and declaring an**  
11 **emergency.**

12  
13 WHEREAS, one of the projects proposed for the expanded Surface Water Management  
14 District is a non-complex design build project to construct wetlands along Idle Brook to reduce  
15 flooding and improve water quality using American Rescue Plan Act funds; and

16  
17 WHEREAS, the Engineer wishes to hire Sustainable Streams, LCC, who conducted the  
18 Yellow Creek Watershed study, to do the criteria engineering needed to get this project ready to  
19 go out to bid including preliminary engineering, hydraulic modeling, conceptual design, field  
20 assessments, outreach, scope drafting for the design-build bid process, and construction  
21 administration and inspection assistance; and

23 WHEREAS, in addition to their prior analysis and study of the Yellow Creek Watershed  
24 for the Summit County Surface Water District, Sustainable Streams, LLC, is an industry leader  
25 in water quality projects and has completed these types of projects in the past making  
26 Sustainable Streams, LLC a Best Practice Source pursuant to Sections 177.01(h)(4)D. and  
27 177.07(a)(5) of the Codified Ordinances of the County of Summit; and

29 WHEREAS, the Board of Control, at its meeting held May 18, 2022, awarded a  
30 professional service contract with Sustainable Streams, LLC, as a Best Practical Source, to  
31 develop the Idle Brook Bankfull Wetlands Project for the Summit County Surface Water  
32 Management District, in an amount not to exceed \$88,500.00, subject to confirmation by this  
33 Council; and

35 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
36 that the aforementioned professional service contract with Sustainable Streams, LLC is necessary  
37 and in the best interest of the County of Summit;

39 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
40 of Ohio, that:

44 The award by the Board of Control of a professional service contract with Sustainable  
45 Streams, LLC, as a Best Practical Source, to develop the Idle Brook Bankfull Wetlands Project

47 \$88,500.00, is hereby confirmed and the Executive is hereby authorized to execute said  
48 professional service contract and any other necessary related documents
