A Resolution confirming the award by the Board of Control of Change Order No. 1 to a Temporary Assistance to Needy Families Agreement with the Akron-Canton Regional Food Bank for food distribution services to food pantries throughout the County, from 10/1/21 through 9/30/22, in an amount not to exceed \$100,000.00, (for a cumulative increase of 37.74%) for a total amount not to exceed \$365,000.00, for the Executive's Department of Job and Family Services, and declaring an emergency.

WHEREAS, this Council previously adopted Resolution No, 2021-258, which authorized the Executive to execute a Temporary Assistance to Needy Families ("TANF") Agreement with the Akron-Canton Regional Food Bank for food distribution services to food pantries throughout the County, from 10/1/21 through 9/30/22, in an amount not to exceed \$265,000.00; and

WHEREAS, the Executive's Department of Job and Family Services wishes to amend its TANF Agreement with the Akron-Canton Regional Food Bank to meet the increased client demand for food distribution services in the County; and

WHEREAS, the Executive wishes to enter into Change Order No. 1 to the TANF Agreement with the Akron-Canton Regional Food Bank to provide the aforementioned additional services; and

WHEREAS, the Board of Control, at its meeting held May 18, 2022, awarded Change Order No. 1 to a TANF Agreement with the Akron-Canton Regional Food Bank for food distribution services to food pantries throughout the County, from 10/1/21 through 9/30/22, in an amount not to exceed \$100,000.00, (for a cumulative increase of 37.74%) for a total amount not to exceed \$365,000.00, subject to confirmation by this Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information that the aforementioned Change Order No. 1 to a TANF Agreement with the Akron-Canton Regional Food Bank is necessary and in the best interest of the County of Summit;
