7 **A Resolution authorizing the Executive, pursuant to Section 177.13 of the Codified**
8 **Ordinances of the County of Summit, to increase the purchase aggregate total for calendar**
9 **year 2022 for various vendors, as set forth in Exhibit A, for the Executive’s Department of**
10 **Sanitary Sewer Services, and declaring an emergency.**

12 WHEREAS, Section 177.13 of the Codified Ordinances of the County of Summit,
13 requires that purchases by an officeholder from any single vendor exceeding \$50,000.00 in the
14 aggregate in any calendar year, where no additional competitive quotes or bids were taken, shall
15 be made only upon authorization of this Council; and

16
17 WHEREAS, the Executive’s Department of Sanitary Sewer Services has vendors that are
18 sole source and best practical source providers for parts and repairs as well as vendors that are
19 used for emergency operations and repairs; and

21 WHEREAS, the Executive wishes to increase the purchase aggregate total for calendar
22 year 2022 for various vendors, for the purposes as set forth in Exhibit A, attached to this
23 Resolution and incorporated herein as if fully restated; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
26 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
27 increase the purchase aggregate total for calendar year 2022 for various vendors, for the purposes
28 as set forth in Exhibit; and

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
31 of Ohio, that:

35 The Executive is hereby authorized, pursuant to Section 177.13 of the Codified
36 Ordinances of the County of Summit, to increase the purchase aggregate total for calendar year
37 2022 for various vendors, as set forth in Exhibit A, attached to this Resolution and incorporated
38 herein as if fully restated.

42 This Resolution is hereby declared an emergency in the interest of the health, safety and
43 welfare of the residents of the County of Summit and for the further purpose of completing
44 repairs and responding to emergency situations as expeditiously as possible.

48 Provided this Resolution receives the affirmative vote of eight members, it shall take
49 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
50 effect and be in force at the earliest time provided by law.
