A Resolution authorizing the Executive to execute an intergovernmental agreement with the City of Akron for the use of the indoor and outdoor firing ranges at the County of Summit Sheriff Robert D. Campbell Training Facility, for a five-year term, from 1/1/22 through 12/31/26, with two options to renew, each for an additional five-year term, for the Sheriff, and declaring an emergency.

WHEREAS, this Council previously adopted Resolution No. 2019-325, which authorized the Executive to execute an intergovernmental agreement with the City of Akron for the use of the aforementioned firing ranges at the aforementioned facility from 1/1/19 through 12/31/19, with five options to renew, each for an additional one-year term; and

WHEREAS, this Council subsequently adopted Resolution No. 2020-399, which authorized the fee schedule for the use of the aforementioned firing ranges at the aforementioned facility; and

WHEREAS, the County and the City of Akron wish to enter into an intergovernmental agreement for use of the aforementioned firing ranges at the aforementioned facility for a term of five-years, from 1/1/22 through 12/31/26, with two options to renew, each for an additional five-year term, in substantially the same form that is attached to this Resolution as Exhibit A, incorporated fully herein; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the County Executive to execute the aforementioned intergovernmental agreement with the City of Akron;

NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The Executive is hereby authorized to execute an intergovernmental agreement with the City of Akron for the use of the indoor and outdoor firing ranges at the County of Summit Sheriff Robert D. Campbell Training Facility, for a five-year term, from 1/1/22 through 12/31/26, with two options to renew, each for an additional five-year term, in substantially the same form that is attached to this Resolution as Exhibit A, incorporated fully herein, with such modifications and revisions as shall be in furtherance of the provisions of said intergovernmental agreement and not substantially adverse to the County, all of which shall be conclusively evidenced by the execution thereof by the Executive.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the residents of the County of Summit, and for the further reason to immediately allow the City of Akron to use the aforementioned ranges at the aforementioned facility in 2022.
