7 **A Resolution confirming the award by the Board of Control of a purchase contract with**
8 **Montrose Ford for the purchase of seven 2022 Ford Explorer police interceptor models, at**
9 **State Term pricing, in an amount not to exceed \$231,995.61, for the Sheriff, and declaring**
10 **an emergency.**

11
12 WHEREAS, it is necessary periodically to replace worn vehicles for use by the Sheriff's
13 Office and the Sheriff budgets annually for such purchases; and

14
15 WHEREAS, due to low inventory of available 2022 Ford Explorer police interceptor
16 models and concerns over continued shipping delays, the Sheriff is requesting First Reading
17 Passage for this purchase contract; and

18
19 WHEREAS, the Executive wishes to enter into a purchase contract with Montrose Ford
20 at State Term pricing to purchase said vehicles; and

21
22 WHEREAS, said vehicles were approved as part of the Capital Improvements Program
23 for 2022-2027 by Resolution No. 2022-032; and

25 WHEREAS, the Board of Control, at its meeting held July 20, 2022, awarded a purchase
26 contract with Montrose Ford for the purchase of seven 2022 Ford Explorer police interceptor
27 models, at State Term pricing, in an amount not to exceed \$231,995.61, subject to confirmation
28 by this Council; and

30 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
31 that the aforementioned purchase contract with Montrose Ford is necessary and in the best
32 interest of the County of Summit;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
35 of Ohio, that:

39 The award by the Board of Control of a purchase contract to Montrose Ford for the
40 purchase of seven 2022 Ford Explorer police interceptor models, at State Term pricing, in an
41 amount not to exceed \$231,995.61, is hereby confirmed and the Executive is hereby authorized
42 to execute said purchase contract and any other necessary related documents.

46 This Resolution is hereby declared an emergency in the interest of the health, safety and
47 welfare of the residents of the County of Summit, and for the further reason to immediately
48 provide for necessary law enforcement vehicles for the Sheriff.

8 effect and be in force at the earliest time provided by law.


