7 **A Resolution approving the Human Resource Commission reclassification of the**  
8 **Prosecutor Secret Service Officer from being a Classified position to an Unclassified**  
9 **position, for the Executive's Department of Human Resources and the Prosecutor, and**  
10 **declaring an emergency.**

11  
12 WHEREAS, this Council has the authority pursuant to Article III, Section 3.03 (10) of  
13 the Charter of the County of Summit and Sections 169.08, 169.09, 169.10 and 169.11 of the  
14 Codified Ordinances of the County of Summit to establish classifications and classification  
15 specifications for all County employees; and

16  
17 WHEREAS, the Prosecutor has requested that the position of Secret Service Officer  
18 within her organization, which is currently vacant, be reclassified from a Classified position to an  
19 Unclassified position pursuant to Section 309.07 of the Ohio Revised Code which defines the  
20 position of Secret Service Officer as an at will position; and

21  
22 WHEREAS, at its meeting held June 16, 2022, at the request of the Department of  
23 Human Resources and the Prosecutor, the Human Resource Commission approved the  
24 reclassification of the Secret Service Officer position from Classified to Unclassified through its  
25 Order 22-01, a copy of which is attached hereto as Exhibit A and incorporated fully herein; and

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
28 that it is necessary and in the best interest of the County of Summit to confirm the Human  
29 Resource Commission reclassification of the Secret Service Officer position from Classified to  
30 Unclassified in order to be compliant with Ohio law;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
33 of Ohio, that:

35 SECTION 1

37 Order 22-01 of the County of Summit to confirm the Human Resource Commission  
38 reclassifying the position of the Secret Service Officer from Classified to Unclassified in order to  
39 be compliant with Ohio law is hereby confirmed and approved.

41 SECTION 2

43 This Resolution is hereby declared an emergency in the interest of the health, safety and  
44 welfare of the residents of the County of Summit, and for the further reason that it is necessary in  
45 order to immediately approve the reclassification of Prosecutor's Secret Service Officer from a  
46 Classified position to an Unclassified position as required by Ohio law.

48 SECTION 3

50 Provided this Resolution receives the affirmative vote of eight (8) members, it shall take  
51 effect immediately upon its adoption and approval by the County Executive; otherwise, it shall  
52 take effect and be in force at the earliest time provided by law.
