8 **An Ordinance amending Section 169.22(c)(4)A of the Codified Ordinances of the County of**  
9 **Summit, entitled “Sick Leave,” to add Aunt and Uncle to the definitions of “Immediate**  
10 **family” as defined in that section, for the Executive and Councilmembers Sims and Schmidt,**  
11 **and declaring an emergency.**

12  
13 WHEREAS, Section 169.22(c)(4)A of the Codified Ordinances of the County of Summit,  
14 entitled “Sick Leave,” sets forth the definitions of “Immediate family” for purposes of sick leave  
15 for use by county employees; and

16  
17 WHEREAS, in an effort to assist Summit County employees and their immediate families  
18 with the ability to age in place, there is a desire to expand the definitions of “Immediate family”  
19 for purposes of approving the use of County Sick Leave, to include an employee’s aunt and uncle;  
20 and

22 WHEREAS, in order to expand qualifying family members as “Immediate family” in  
23 Section 169.22(c)(4)A of the Codified Ordinances of the County of Summit, the Executive  
24 proposes that the County amend said section to add Aunt and Uncle for the purposes of the  
25 approved use of County sick leave; and

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
28 that it is necessary and in the best interest of the County of Summit to amend Section 169.22(c)(4)A  
29 of the Codified Ordinances of the County of Summit for the reasons set forth above;

31 NOW, THEREFORE, BE IT ORDAINED by the Council of the County of Summit, State  
32 of Ohio, that:

34 SECTION 1

36 Section 169.22(c)(4)A of the Codified Ordinances of the County of Summit, entitled “Sick  
37 Leave,” is hereby amended as set forth on Exhibit A, attached hereto and incorporated herein by  
38 reference.

40 SECTION 2

42 This Ordinance is hereby declared to be an emergency in the interest of the health, safety  
43 and welfare of the residents of the County of Summit and to immediately benefit the habitats of  
44 pollinating insects in the County.

46 SECTION 3

48 Provided this Ordinance receives the affirmative vote of eight members, it shall take effect  
49 immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and  
50 be in force at the earliest time provided by law.


